**Sample 2(a) – claim by an individual against a corporation**

You hired a roofing company to repair your roof after a hail storm. The roofing company carries on business under the name "Rainy's Roofing." The roof leaks after the repair and you want to make a claim against the roofing company.

You have done a Companies Office search and found out that the roofing company is incorporated and its corporate name is "Rainy's Roofing (1998) Inc."

**Sample 2(b) – Counterclaim by a corporation against an individual**

As in Sample 2(a), you are the defendant corporation that repaired the claimant’s roof. The claimant put a stop payment on his cheque so you have not been paid for the work you did. You file a Counterclaim ([Form 76E](#)) against the claimant for the amount of the invoice.

The Counterclaim is filed on the same file as the Small Claim. The claimant remains the claimant and the defendants remain the defendants.

**Sample 3 – claim by a corporation against an individual carrying on business as a sole proprietor**

Your company supplies plumbing products to plumbers and their businesses. In an application for credit, a plumbing business's owner gave a personal guarantee in writing to be responsible for paying his business's accounts.

You have done a Companies' Office search and found out that the plumbing business is not incorporated and the individual carries on business as a sole proprietor under the business name Best Plumbing.

**Sample 4 – claim by an owner and driver against a driver and the City of Winnipeg regarding a motor vehicle accident**

You are 19 years old and were driving a car registered in your father’s name. You were in a motor vehicle accident with a Winnipeg Transit bus. The Manitoba Public Insurance Corporation has found you, the driver, 100% at fault and your father, the owner, has to pay the \$200 deductible. You want to make a claim for the \$200 deductible and you want the court to find that the Winnipeg Transit bus driver was 100% at fault for the accident.

**NOTE:** If you are making a claim about whether you are at fault for a car accident, you must deliver a copy of the claim in person or by registered mail to the Manitoba Public Insurance Corporation either at the MPI Legal Department, at the 8<sup>th</sup> floor–234 Donald Street, P.O. Box 6300, Winnipeg, MB, R3C 4A4 or to an MPI Service Centre in Manitoba (For a listing of MPI Service Centres in Manitoba please go to: [http://www.mpi.mb.ca/en/Reg-and-Ins/Registration/Pages/reg\\_service-outlet.aspx](http://www.mpi.mb.ca/en/Reg-and-Ins/Registration/Pages/reg_service-outlet.aspx) ).

**Sample 5 – claim against a partnership**

You hired a business to install flooring in your home and the business did not complete the job, although you paid in full for the materials and labour. The flooring business is carried out by a mother and son partnership in the firm name "Flooring Experts".

You may bring the claim against the name of the partnership only, in which case you must serve any member of the partnership, or you may bring the claim against the partnership and name all the partners as individual defendants, in which case you must serve all the named defendants. (You may need legal advice on when it is appropriate to proceed against the partnership in the firm's name only, or when it is appropriate to name the partners personally.)

In this sample, the claimant has named the partnership and the two individual partners as defendants.
