PROVINCIAL COURT OF MANITOBA

**RE: RESUMPTION OF JUDICIAL JUSTICE OF THE PEACE DOCKETS
IN THE COMMUNITIES OF CROSS LAKE, GODS LAKE
NARROWS, NELSON HOUSE, NORWAY HOUSE, OXFORD
HOUSE, SHAMATTAWA, AND SPLIT LAKE.**

April 19, 2022

Effective May 2, 2022, Judicial Justice of the Peace (JJP) dockets will resume sitting in person in the communities of Cross Lake, Gods Lake Narrows, Nelson House, Norway House, Oxford House, Shamattawa, and Split Lake.

The Provincial Court of Manitoba, including JJP dockets, remains closed to members of the public until June 27, 2022. Only those with a court appearance are permitted to attend.

In order to minimize the number of people attending court in person at one time, going forward, the JJP dockets will be divided alphabetically into morning and afternoon sittings as set out below. Persons attending court prior to their designated time will be directed not to enter or remain in the vicinity of the court facility and will be instructed to return for their court appearance at the assigned time.

This procedure will continue at each scheduled date for Judicial Justice of the Peace dockets in the named communities until further notice. Those with matters on the JJP docket are directed to appear as set out below:

For all communities, **youth** matters will appear at 10:00 a.m.

Cross Lake

Last names beginning with A-M appear at 10:00 a.m.

Last names beginning with N-Z appear at 2:00 p.m.

Gods Lake Narrows

Last names beginning with A-N appear at 10:00 a.m.

Last names beginning with O-Z appear at 2:00 p.m.

Nelson House

Last names beginning with A-M appear at 10:00 a.m.

Last names beginning with N-Z appear at 2:00 p.m.

Norway House

Last names beginning with A-M appear at 10:00 a.m.

Last names beginning with N-Z appear at 2:00 p.m.

Oxford House

Last names beginning with A-H appear at 10:00 a.m.

Last names beginning with I-Z appear at 2:00 p.m.

Shamattawa

Last names beginning with A-M appear at 10:00 a.m.

Last names beginning with N-Z appear at 2:00 p.m.

Split Lake

Last names beginning with A-G appear at 10:00 a.m.

Last names beginning with H-Z appear at 2:00 p.m.

Since the beginning of the COVID-19 pandemic, the Provincial Court of Manitoba has taken proactive preventative measures to protect the health and safety of all court participants to help contain the spread of COVID-19, while providing judicial services to Manitobans. All persons attending to the court facility will be subject to the same COVID-19 screening protocols previously implemented for sittings of the Provincial Court in each community. It is important that all court participants continue to practice social distancing, continue to wear masks and follow the direction of Sheriff officers and COVID screeners when attending court.
