RE: Courtroom Designations

In an effort to improve Court efficiency and respond to the current needs of the justice system, the Provincial Court, Winnipeg Centre, has modified the Courtroom Designations, effective April 3, 2023.

Summary of Changes to Courtroom Designations:

Monday

The Federal Administrative docket will no longer sit on the 3rd Monday morning of the month.

NEW Federal Administrative matters will now appear at 2:00 p.m. in courtroom **303** on the Federal Complex docket as arranged by the Federal Crown.

Youth first appearances will no longer appear on the PCC docket.

NEW Youth first appearances will now appear on the 2nd and 4th Mondays of the month at 10:00 a.m. in courtroom **402**.

Tuesday

NEW The Legal Aid Administrative docket will now appear on the 2nd Tuesday of the month at 9:30 a.m. in courtroom **401**.

Wednesday

NEW All Federal dispositions will now be heard at 10:00 a.m. and 2:00 p.m. in courtroom **303**.

Thursday

Federal out of custody PTC matters will no longer appear on the PCC docket.

NEW All Federal PTC matters (both in custody and out of custody) will now appear at 9:15 a.m. on the 2nd and 4th Thursdays of the month in courtroom **316**.

The Provincial waive in docket will now appear at 10:00 a.m. in courtroom **401**.

Private Prosecution first appearances will appear on the 3rd Thursday of the month at 2:00 p.m. in courtroom **306**.

Monday to Friday

NEW The 2:00 p.m. docket in courtroom 306 will be used exclusively for first appearances on motions, same day guilty pleas transferred from the PCC docket or contested matters transferred from the PCC docket.

The new Courtroom Designation is effective **April 3, 2023**. Please see the revised Courtroom Designation Chart attached.
