In an effort to provide timely access to justice and ensure court resources are allocated in a manner that reflects the specific needs of all communities throughout the province of Manitoba, the Provincial Court will be reducing the number of circuit court sittings in a number of locations.

Altona: Effective July 24, 2023, Altona will sit every second month.

Current scheduled sittings remain unchanged: September 25 and November 27, 2023; January 22 and March 18, 2024.

The following sittings are cancelled: August 28, October 30 and December 18, 2023; February 26, 2024.

Arborg: Effective October 16, 2023, Arborg will sit every second month.

Current scheduled sittings remain unchanged: December 4, 2023; February 5, 2024.

The following sittings are cancelled: January 8 and March 4, 2024.

Emerson: Effective October 18, 2023, Emerson will sit the 3rd Wednesday of the month (Child Protection, Criminal Docket) and the 2nd Thursday of every 2nd month (Criminal Trials and Dispositions).

Current scheduled Thursday sittings remain unchanged: June 8, July 13, August 10 (August 24 is cancelled), September 14, and November 9, 2023; January 11 and March 14, 2024.

The following sittings are cancelled: August 24, October 12, November 23, and December 14, 2023; January 25, February 8, 2024.
